5. Open Round Table Discussion/Questions

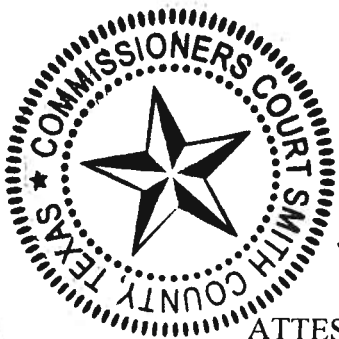
Commissioner JoAnn Hampton and Auditor Ann Wilson led a discussion on Indigent Defense Attorneys form.


6. Future Agenda Items / Set Date & Time for Next Meeting
