IT IS FURTHERMORE ORDERED that the appointment of the below named individuals shall be for a period ending January 31, 2009 and may be renewed for additional terms of two (2) years.

IT IS FURTHERMORE ORDERED that any Private Process Server subject to this Order shall notify the Smith County District Clerks in writing of any change of address within ten (10) business days of said change.


