COMES NOW \_\_\_\_\_, herein after called defendant, in the above numbered and entitled cause and files this Motion and Application for Work Release Privilege and as grounds would show the court as follows: I have been sentenced or will be sentenced to jail time in this case and I am requesting that I may be allowed to serve the sentence in such a manner that I might be able to keep and maintain my employment so that I will not become a further financial burden on the government and people of this city and county. In asking for this accommodation, I accept the following terms and conditions and make the following promises and statements to the court under oath. **I understand that if I am ever late in arriving at the jail, the time remaining on my sentence will be served without release until the sentence is completed. I understand that if I arrive at the jail and have been drinking or consuming any alcoholic beverages or using drugs, the time remaining on my sentence will be served without release until the sentence is completed. I understand that if I am arrested for another criminal offense, I expect and agree that the time remaining on my sentence will be served without release until the sentence is completed. I understand and agree that it is a felony offense to bring alcoholic beverages, firearms, controlled substances, dangerous drugs, explosive weapons, or illegal knives into any facility that is the Smith County Jail or into an office utilized by a court. I understand and promise that I am and will continue to be employed in the position and during the hours stated in this application, during the time period of my work release ordered by the Court, and I further understand that if my hours of employment or my employment changes during the service of my sentence I will immediately, within five hours, advise the officers of the Smith County Jail of said change. I ask the court to grant work release and as an inducement to the Court to grant said work release I make the following verified statements.**
