

# CLASS "A" & "B" MISDEMEANOR 2020 - 2021 ARRAIGNMENT SCHEDULE

---

The attached schedule is based on arrest dates only, except for arrest on capiases. When a Defendant is arrested on a capias/alias capias, this schedule should be checked for the next closest arraignment date in order for the case to be placed back on the appropriate court's docket. Oftentimes a Defendant is arrested on a bond forfeiture, surety to surrender principal (SOB) or an insufficient bond warrant, in which case the court should be contacted to determine whether a new arraignment date is necessary.

The **APPEARANCE DATE AND TIME OF 8:00 A.M.** (no exceptions) must be written in the proper place on the bond in order to identify the appropriate court. Further, all Defendants are hereby **ORDERED** to appear without exception.

Usually all case numbers beginning with "001" are assigned to the **County Court at Law, Judge Jason Ellis, Presiding**, unless the case was ordered transferred to a different court.

Usually all case numbers beginning with "002" are assigned to the **County Court at Law #2, Judge Taylor Heaton, Presiding**, unless the case was ordered transferred to a different court.

Usually all case numbers beginning with "003" are assigned to the **County Court at Law #3, Judge Floyd T. Getz, Presiding**, unless the case was ordered transferred to a different court.

**NOTICE:** Please note that there are a few "Thursday" arraignment docket dates. They are in bold print.
