Defendants are ordered to appear, without exception, at the times assigned herein unless otherwise ordered by the Court. Defendants in custody shall be transported to Court at a time designated by each Court according to the date of arrest.

THE APPEARANCE DATE AND TIME , WHICH IS ALWAYS 8:30 A.M., MUST BE WRITTEN IN THE PROPER PLACE ON THE BOND IN ORDER TO IDENTIFY THE PROPER COURT.
